Summary Annual Report

Carpenters-Employers Vacation Plan of Western Washington

This is a summary of the annual report of the Carpenters-Employers Vacation Plan of Western Washington, E.I.N. 23-7163058, Plan No. 501, for the year ended December 31, 2020. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Trustees, Carpenters-Employers Vacation Plan of Western Washington, has committed itself to provide certain vacation benefits incurred under the terms of the plan.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$1,074,795 as of December 31, 2020, compared to \$1,082,408 as of January 1, 2020. During the plan year, the plan experienced a decrease in its net assets of \$7,613. During the plan year, the plan had total income of \$13,380,938 including employee contributions of \$13,378,174 and earnings from investments of \$2,764.

Plan expenses were \$13,388,551. These expenses included \$90,276, in administrative expenses and \$13,298,275 in benefits paid to or for participants and beneficiaries.
