Summary Annual Report

Northwest Carpenters Health and Security Plan

This is a summary of the annual report of the Northwest Carpenters Health and Security Plan, E.I.N. 91-6029049, Plan No. 501, for the year ended December 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Trustees of the Northwest Carpenters Health and Security Plan has committed itself to pay certain medical, prescription, dental, vision, and time loss claims incurred under the terms of the Plan.

Insurance Information

The Plan has contracts with UnitedHealthcare of Washington, Inc., Kaiser Foundation Health Plan of the Northwest, and LifeMap Assurance Company to pay life insurance and health benefits incurred under the terms of the Plan. Total premiums paid for the plan year ended December 31, 2022, were \$16,811,349.

Because certain insurance contracts are experience rated, the premium costs are affected by, among other things, the number and size of claims. Premiums paid under experience-rated contracts for the plan year ended December 31, 2022 were \$1,157,867 and the total of all benefit claims paid under experience-rated contracts during the plan year was \$1,228,456.

Basic Financial Statement

The value of Plan assets, after subtracting liabilities of the Plan, was \$273,616,876 as of December 31, 2022, compared to \$285,818,593 as of January 1, 2022. During the plan year, the Plan experienced a decrease in its net assets of \$12,201,717. This decrease includes realized and unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the Plan had total income of \$213,195,817, including employer contributions of \$238,237,319, employee contributions of \$10,334,202, loss from investments of \$44,953,122 and other income of \$9,577,418.

Plan expenses were \$255,397,534. These expenses included \$7,371,777 in administrative expenses and \$218,025,757 in benefits paid to or for participants and beneficiaries.
