

# Summary Annual Report

## Carpenters-Employers Vacation Plan of Western Washington

This is a summary of the annual report of the Carpenters-Employers Vacation Plan of Western Washington, E.I.N. 23-7163058, Plan No. 501, for the year ended December 31, 2016. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Trustees of the Carpenters-Employers Vacation Plan of Western Washington has committed itself to provide certain vacation benefits incurred under the terms of the plan.

### Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$11,380 as of December 31, 2016, compared to \$71,105 as of January 1, 2016. During the plan year, the plan experienced a decrease in its net assets of \$59,725. During the plan year, the plan had total income of \$12,971,611 including employee contributions of \$12,951,575, earnings from investments of \$1,099 and other income of \$18,937.

Plan expenses were \$13,031,336. These expenses included \$79,761, in administrative expenses and \$12,951,575 in benefits paid to or for participants and beneficiaries.

1. An independent auditor's report;
2. Financial information and information on payments to service providers;
3. Assets held for investment; and
4. Transactions in excess of 5% of the plan assets.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
